National Policies

National Player Registration and Transfer Regulations

Governs the eligibility, registration and transfer of players including interchange agreements and permits.

National Member Protection Policy

Governs the standards of behaviour of all stakeholders involved in Australian Football and the dispute resolution framework.

National Vilification and Discrimination Policy

Governs the process to resolve and/ or determine incidents of alleged vilification or discrimination.

National Player and Official Deregistration Policy

Governs the criteria and process for the deregistration and re-registration of players and officials relating to sanctions imposed for reportable offences.

National Policies continued...

National Child Protection Policy

Guidelines to Leagues and Clubs to ensure a safe and inclusive environment for all children in Australian Football and to assist with their obligations under child protection laws.

National Age Dispensation Policy

Policy providing for the dispensation of player to participate in underage competitions where a disability, physical size and/ or development considerations exist.

National Disciplinary Tribunal Guidelines

Governs the reporting and determination process with respect to disciplinary or conduct related matters which are not Reportable Offences (i.e. off-field conduct).

State Policies

State & Territory Tribunal Guidelines NSW/ACT

Governs the reporting and tribunal process with respect to Reportable Offences (i.e. on-field).

AFL NSW/ACT Regulations

Regulations applying to all leagues and clubs governing the administration of all community competitions within AFL NSW/ACT's jurisdiction.

League By-Laws

League specific rules and laws governing the conduct of a League's competitions.

League Affiliation & Services Agreement

Agreement between AFL NSW/ACT and affiliated Leagues outlining the benefits of affiliation with AFL NSW/ACT, services to be provided to the League, AFL NSW/ACT's requirements for affiliation and fees payable.

Club Participation Agreement

Agreement between the League and Club regarding the terms and conditions applying to the Club's participation in League's competitions for the relevant season.

AFL NSW/ACT Approved Use of Logo

Full Colour Logo

Use wherever possible. It will be used in most applications (print, advertising, web, TV and merchandise). It is reproduced in either PMS, CMYK or RGB. Always choose the right artwork for your medium.

Mono Logo

Use only if colour cannot be used. This Logo can be used on a solid background. Please ensure the white keyline is visible if used on a coloured background.

Reversing the AFL NSW/ACT Corporate Brand

The brand may be reversed from a coloured background or a photographic image. Care should be taken to ensure that no background detail interferes with the brand or makes it illegible. Ensure that the ® symbol is always visible by reversing it from the background colour.

Incorrect Usage

When using the AFL NSW/ACT Corporate Brand, it is important to ensure it is not altered in any way.

The AFL NSW/ACT Corporate Brand must be treated with respect at all times and its integrity must remain intact. Variations or treatments such as those illustrated here are not permitted.



Do not use the Logo against a highly detailed background.



Do not alter the colour of the Logo. It must only be used in the approved colourways.



Do not alter the typeface of the Logo.



Do not rotate the Logo.



Do not remove or rearrange elements of the Logo.



Do not re-colour individual Logo elements.



Do not stretch or distort the Logo.



Do not crop the Logo. It must be used in its entirety.
